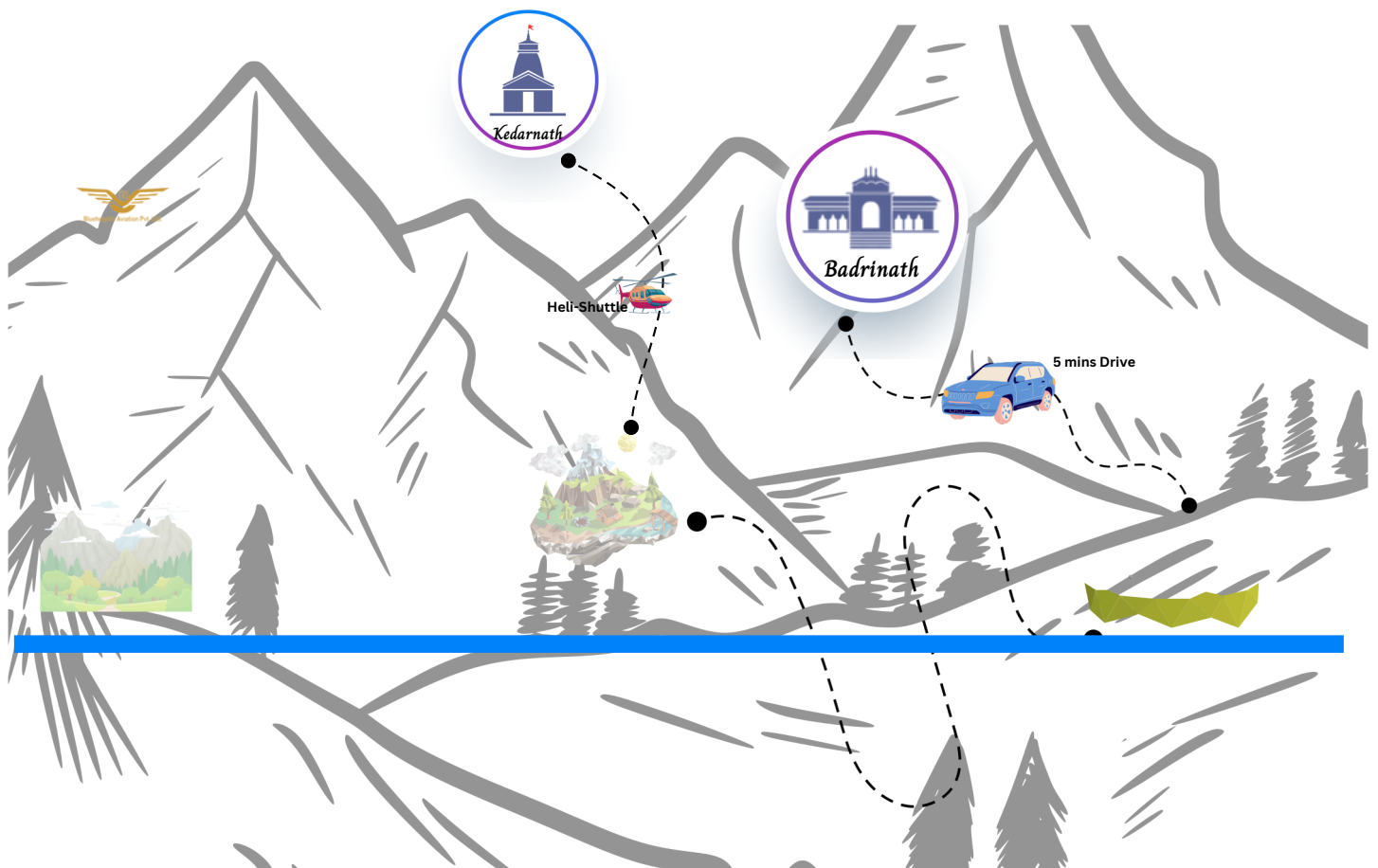

DAY: 1 (DEHRADUN)

- Arrival: Passengers are responsible for reaching the Dehradun hotel on their own.
- Transfers: Arrival details must be provided to Safe Fly Aviation at the time of booking if airport or railway station transfers are required (available on a chargeable basis).
- Check-in Time: Passengers should aim to reach Dehradun by 02:00 pm or earlier to be fully prepared for the Dodham journey early the next morning.
- Briefing: In the evening, our team will conduct a tour briefing for all passengers.
- Luggage: We provide complimentary duffel bags for carrying essentials. Only up to 5 kg per person is permitted, depending on actual body weight.





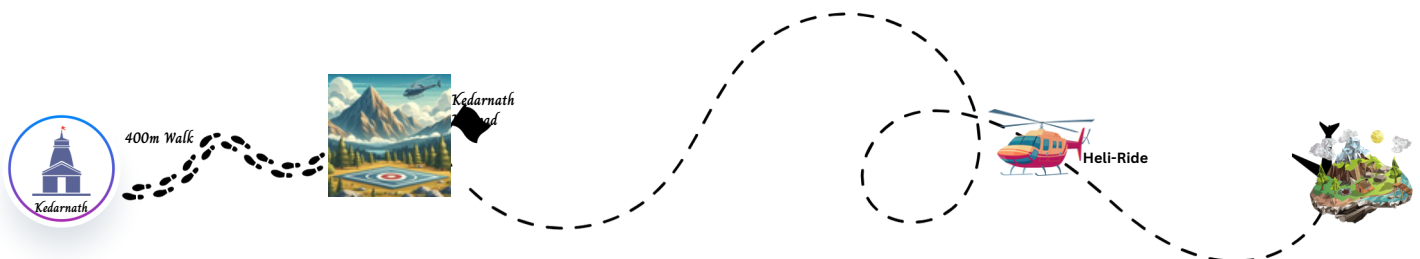
DAY: 2 (KEDARNATH DHAM)
(SAHASTRADHARA TO SERSI TO KEDARNATH)

Hotel - KedarKantharesort / Similar

Tentative Itinerary:

1400hrs	ETD from Sahastradhara Helibase
1430hrs	ETA at Guptkashi / Sersi / Phatta

- Passengers are required to reach Sahastradhara Helidrome as per advised time one night prior, and then will arrival at Sersi / Phatta / Guptkashi.
- Passengers will be ferried to Kedarnath from Sersi / Phatta / Guptkashi in helicopter shuttle.
- From Kedarnath helipad, Passengers will have to walk till the temple and will be assisted by our handlers for VIP darshans.
- It takes approximately 02 hours for Dharshans & Helicopter shuttle takes around 7 minutes one way.
- After darshan, passengers will be ferried back to Guptkashi / Sersi / Phatta and will be transferred by road to their hotel in Guptkashi or else night stay at Kedarnath Ji guest house.
- In evening passengers will be taken to Kali Temple by road for local sight seeing (subject to weather and traffic conditions) if staying at Guptkashi.





DAY: 3 (BADRINATH DHAM)
(SERSI TO BADRINATH)

Hotel - Lord'sCentric / Similar

Tentative Itinerary:

0900hrs	ETD from Guptkashi / Sersi / Phatta
0930hrs	ETA at Badrinath

- Passengers will check-out from Guptkashi hotel and will be transferred to Sersi / Phatta / Guptkashi by Road and then will take a helicopter ride to Badrinath as per the advised time one night prior.
- After Landing at Badrinath, passengers will be checked-in to their hotel
- Post-Breakfast, passengers will be taken for VIP darshan to Badrinath Ji with the assistance of our handlers.
- After Darshans, passengers will be provided with good lunch in the hotel restaurant and post lunch they'll be taken to Manna Gaaon for Local Sight-Seeing tour by Road. (3km by car & approx. 4km sight seeing tour on foot)
- In evening, Passengers can Experience Shayan Aarti on direct payment basis at Badrinath Ji.



DAY: 4 (BADRINATH TO SAHASTRADHARA)

In Morning, Passengers will check-out of Badrinath Hotel and catch the flight back to dehradun

TERMS, CONDITIONS & GUIDELINES

FIXED FLIGHT TIMINGS



This helicopter tour operates with fixed daily departure times for each destination. Passengers are required to adhere to the scheduled Estimated Time of Departure (ETD) for each day of the tour. Failure to do so will result in being marked as a NO-SHOW.

COVID TRAVEL GUIDELINES



Passengers and Safe Fly Aviation must strictly follow COVID protocols in accordance with the prevailing government mandates. Non-compliance with government guidelines may result in the denial of boarding to passengers, and refunds will not be provided in such cases.

HELICOPTER WEIGHT LIMITATIONS



The helicopter has a maximum weight capacity of 420 kg, excluding baggage weight. Passenger boarding depends on load and temperature conditions, with the pilot's decision being final. The total weight of all passengers on board must not exceed this limit. Therefore, passengers are requested to provide their exact weights at the time of booking.

PASSENGER WEIGHTS



Passengers are required to accurately provide their weights at the time of booking. In the event of any weight discrepancy discovered during travel that exceeds our aircraft's weight capacity of 420 kg, affected passenger(s) will be de-boarded and the Heli-tour will be canceled them and without any refund.

OVERWEIGHT CHARGES : ON PER SEAT BASIS ONLY



Excess weight charges for the Do-dham helicopter tour are set at INR 2500 per kilogram, applicable to passengers whose weight exceeds 70 kg.

Moreover, if there is any variance in the passengers' weights, subject to charges based on the overweight criteria, the corresponding amount will be collected at the helipad before the flight boarding.

BAGGAGE ALLOWANCE



Each passenger is allowed only one piece of baggage, weighing a maximum of 2-5 kgs. Helicopter travel does not permit suitcases or other traditional luggage bags. To address this, our staff provides duffel bags to all passengers upon arrival. The allowance for baggage weight is based on the total body weight of the group. If the combined body weight of the group exceeds the allowable limit of 420 kg, additional charges will apply for transporting the excess luggage by road, and this cost will be shared among all passengers in that chopper.

Due to the constrained weight capacity of our helicopters, we retain the right to rearrange passengers among helicopters to ensure the optimal weight for safe flying in mountainous terrain. Consequently, passengers traveling together may not necessarily be accommodated in the same helicopter flight.

ARRIVAL DATE



Our Dodham Sameday Heli-tours are reserved on specific departure dates. Passengers are required to reach Dehradun one day prior to the departure date. The night stay in Dehradun on the arrival date will be on the cost of the traveler and can be arranged by Safe Fly Aviation Team on chargeable basis.

SEATING CAPACITY



Our helicopters have a maximum seating capacity of 06 passengers, accompanied by 01 crew member.

INFANT



Infants below 2 years weighing up to 12 kg are accommodated free of charge. To verify the age of the child, we will check the child's ID proof or birth certificate.

BAD WEATHER AND FORCE MAJEURE DISCLAIMER



Helicopter flights in hilly terrain are contingent upon unpredictable factors such as adverse weather conditions and various Force Majeure events. These include delayed Air Traffic Clearances/Permissions, VVIP movements, valley flying by the Indian Air Force (NOTAM), sudden technical issues in the aircraft, illness of the flying crew, or delayed reporting of passengers at the helipads, among other unforeseen circumstances.

Passengers are advised to be ready to encounter any unexpected events and inconveniences that may arise in such situations.

The complete payment needs to be settled in cash with Safe Fly Aviation's representative at Badrinath. This enables us to make the necessary arrangements and pre-book the Puja on behalf of each passenger.

Please note that the Maha Abhishek Puja is not encompassed within our package or billing cost. The total amount for this Puja is directly payable to Badrinath Ji Mandir Samiti. Confirmation is subject to Availability upon arrival at Badrinath.

RUDRA-ABHISHEK PUJA AT KEDARNATH JI : On actual Cost basis

The full payment should be made in cash to Safe Fly Aviation's representative at Kedarnath top. This payment is essential for us to coordinate and pre-book the Puja on behalf of each passenger.

The arrangement for Rudra Abhishek Puja is contingent upon the availability of rooms at Kedarnath-Top, as passengers might be required to stay overnight for the Puja. Consequently, additional charges for hotel accommodation will be applicable.

Our team is dedicated to managing your complete Dodhamtour, and we are also available to aid you in securing air or train tickets to or from Dehradun.

EXTRA NIGHT STAY AT DEHRADUN: PRICE ON DEMAND.

Should you require an extra night stay in Dehradun, our team is ready to handle your hotel reservations. It's worth noting that we secure hotels at the most competitive rates available.

- The confirmation for above services is to be given in advance by clients, at the time of booking of Heli Tour.
- Airport transfers will be not provided only on the arrival day at Dehradun, and on the last day, i.e., 4th day of the tour.
- Any donations, tips, pitthu, palki/pony and porter charges shall be borne by the passengers.
- AADHAR Card copies are to be shared by all Indian passengers, & passport in case of foreign nationals.
- Safe Fly Aviation has its own crew at both the Dhams. For any guidance or assistance, passengers are free to reach out to them.
- Network connectivity at Harsil & Badrinath is very poor. BSNL & Jio are the main telecom services, that work in these regions mostly, but not always. However, our staff shall be with the passengers for assistance at all times.
- All temples in Chardham sector are located at high altitude, therefore passengers are advised to carry medication during travel. Also, they are advised to carry heavy woolen clothing with them, because during evenings & nights, the temperature can drop drastically.

MEDICAL EMERGENCIES

Safe Fly Aviation assumes no responsibility for medical emergencies occurring on the ground for passengers. To safeguard your well-being, we strongly recommend that passengers consult a doctor and undergo a medical check-up before embarking on the journey, especially if they have any pre-existing medical conditions.

CARRIAGE BY AIR ACT, 1972

The carriage is subject to Safe Fly Aviation Services regulations relating to the conditions of Non-International Carriage (Passenger and Baggage) framed in accordance with The Carriage by Air Act, 1972 and Notification regarding application of the carriage which is non-international. PAYMENT TERMS

*Advance booking requires a 35% deposit of the total amount. The remaining balance must be settled 40 days before the scheduled arrival date in Dehradun.

*Passengers are only allowed to board or initiate the tour after completing the full and final payment for the tour.

The booking amount is non-refundable; however, a credit note will be issued if feasible conditions are met. (Conditions also apply for B2B bookings.)

ADDITIONAL SERVICES: Deduction of any additional services provided at any of the Dhams during the tour of the passengers will be deducted over & above the refundable Tour Cost.

Refund against any unutilized service will not be calculated separately and added to the refundable amount.

If flying is not possible due to bad weather at Dehradun, then 12 % will be deducted and balance will be refunded to guest.

Refunds will be settled in the form of a CREDIT NOTE only.

COVID-19 CASE, OR ANY NATIONAL/STATE EMERGENCY

If passengerstestpositivefor COVID before their scheduled travel, if the Yatra is canceled by the government, or in the event of a National or State emergency, no refunds will be issued. Nevertheless, passengers experiencing cancellations due to lockdown will receive a Credit Voucher from Safe Fly Aviation. This voucher, equivalent to the advance payment, remains valid for one year and can be utilized for any of our helicopter tours or charter services. Passengers, as well as their friends or relatives, can redeem the full value of the credit voucher during this period. FORCE MAJEURE & BAD WEATHER POLICIES

- **Liability & Control:** In the event of flight cancellations or delays due to bad weather, technical issues, or force majeure reasons beyond the control of Safe Fly Aviation Pvt Ltd Services, the company will not be held liable. Such inconveniences are beyond the operator's control.
- **Refund Policy:** If a flight is cancelled, clients are entitled to a refund in accordance with our refund policy. However, no compensation or reimbursement will be provided for accommodation, transportation, meals, or any additional travel expenses incurred.
- **Day One Cancellations:** If the tour cannot depart from Dehradun on Day One for the reasons mentioned above, the tour will be deemed cancelled. A full refund, minus 12%, will be issued according to our policies.
- **Rescheduling:** If passengers wish to reschedule for the next available date, they may initiate a new booking. Our team will present available options, and the unused amount from the previous booking can be applied toward the new one. Any additional costs are the responsibility of the passengers.
- **Ongoing Tour Disruptions:** If a tour is disrupted after departing from Dehradun, our team will propose a revised itinerary within the original scheduled package days. No extensions will be granted without extra cost and are subject to operational viability.
- **Passenger Priority:** New Chardham passengers scheduled for departure on their respective dates will take priority over backlog passengers from previous days.
- **Additional Costs:** If passengers are stranded for additional nights due to bad weather or force majeure, any extra hotel night halt charges must be paid by the passengers directly to the hotels.

If any passenger(s) require ferry flights to be operated for them in emergency, cost for the same will be charged to the party @ INR 175,000/hr plus GST.

While the tour is ongoing, if any group demands to cancel their tour mid-way, the arrangement of transportation will be done by OUR TEAM, however, cost for the same will be borne by the passengers on direct payment basis.

Any increase in government levies or taxes or special Darshan or Palki after the confirmation of booking, will be extra chargeable to the passengers. Payment against the same will have to be made before the commencement of tour.
